AGREEMENT

This agreement is entered into on *[start date]*, by and between The Regents of the University of California, on behalf of the Department of Statistics, Statistical Consulting Center, of its Los Angeles campus, hereinafter called University and *[client]*, Client

Whereas Client desires to use the services of the Statistical Consulting Center, specifically *[consultant]*, an employee of the university, for the project *[project name]* and

Whereas University is willing that *[consultant]* provide such services but wishes to be reimbursed for the portion of his/her compensation related to such services;

Now, Therefore, the parties agree as follows:

1. Agreement (see attached Statement of Work Exhibit A) will be effective *[start date]* through *[end date]* .
2. Estimated budget request:

4. Termination

- (a) This agreement may be terminated by either party by giving thirty (30) days advance written notice of party's intent to terminate.
- (b) Termination of this agreement shall not affect the right and obligations of the parties accrued prior to termination. As its sole liability upon termination, Client shall pay University for all expenses incurred or committed to be expended as of the effective termination date.
- (c) Any provisions of this Agreement which by their nature extend beyond termination hereof shall survive such termination.

5. This agreement shall be governed by, construed, and enforced, in accordance with the laws of the State of California.
